






Response Rate per Region





5. DID YOU RECEIVE ACADEMIC COURSES OR TRAINING ON PROFESSIONAL ETHICS?




- Academic education: should include professional and research ethics (90% Y)



7. DID YOU UNDERGO ANY CPD ACTIVITIES IN PROFESSIONAL ETHICS?







DISCONNECT BETWEEN PROFESSIONAL ETHICS AND PRACTICE



ADVICE FROM CLINICIANS AND HEALTHCARE PROFESSIONALS

ETHICAL CLEARANCE PROCESSES NOT WIDESPREAD LACK OF SPECIFIC EDUCATION (ALL LEVELS) IN PROFESSIONAL ETHICS
